#### **ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS3 Single-Unit Detached House District symbols and indications as shown on Map No. 14-G in the area bounded by:

line 22.30 60<sup>th</sup> feet north of and parallel the north line of West Street. to South Green Street, West 60<sup>th</sup> Street, the public alley next west of South Green Street

to those of a RT4 Residential Two-Flat, Townhouse and Multi-Unit District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.






