ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the RS-3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No.3-G in the area bounded by

West Fry Street; a line 129.56 feet east of and parallel to North Ashland Avenue; the alley next south of and parallel to West Fry Street; and the alley next east of and parallel to North Ashland Avenue,

to those of a RM-5 Residential Multi-Unit District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

The existing two-story single-family home will be razed. The proposed zoning amendment will allow the Applicant to redevelop the site with a new four-story (with basement), four-unit, all residential building (approx. 6,138 sq. ft.). The proposed new building would offer a detached, four-car garage at the rear of the lot. The proposed new building would also offer a rooftop deck above the garage, as well as private porches off the rear of the dwelling units located on the 2nd, 3rd and 4th floors and private balconies off the front of each of the four dwelling units. The proposed building will be constructed to a height of 44'-10".
