ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION I. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, Is hereby amended by changing all the B1-2 Neighborhood Shopping District symbols and indications as shown on Map No. 11 -G in the area bounded by

The alley next North of and parallel to West Irving Park; North Southport Avenue; West Irving Park Road; and a Line 54.60 feet west of and parallel to North Southport Avenue,

to those of a B3-3 Community Shopping District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
