That the Chicago Zoning Ordinance be amended by changing all the current M3-3 Heavy Industry District symbols and indications as shown on Map No. 5-H in the following area: North Honore Street; North Elston Avenue; West Webster Avenue; and the alley next west of North Elston Avenue to those of a M2-3 Light Industry District which is hereby established in the area described above. SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication March 1.2011 Chairman, Committee on Zoning Room 304, City Hall Chicago, Illinois 60602 Chairman: The undersigned, Rolando R. Acosta, being first duly sworn on oath, deposes and say the following: That the undersigned certifies that he has complied with the requirements of the Chicago Zoning Ordinance, Title 17, Section 13-0107-A of the Municipal Code of Chicago, by serving written notice by USPS first class mail, to the owners of all property within 250 feet in each direction of the lot lines of the subject property, the boundaries of which are:

North Honore Street; North Elston Avenue; West Webster Avenue; and the alley next west of North Elston Avenue

(hereafter the "Property") will be filed on or about March 2, 2011 with the Department of Housing and Economic Development, City of Chicago by 2230 Elston, LLC, 2222 N.
