bargaining agreements regardless of bargaining unit and regardless of department; employee benefits; matters affecting pensions of city employees, regardless of pension fund; and all other personnel matters generally relating to the City government, excepting claims under the Workers' Compensation Act. The Committee's jurisdiction shall also include efforts intended to expand the city's private workforce and to create increased job opportunities in the city's private sector through business attraction efforts, business retention efforts, relocation services, incentive programs, training and retraining programs, or any other

means.
