Description: The Committee on Environmental Protection and Energy shall have jurisdiction over all legislation relating to the abatement of air, water and noise pollution; solid waste collection and disposal; recycling and reuse of wastes; conservation of natural resources; and with all other matters not specifically included dealing with the improvement of the quality of the environment and the conservation of energy. The Committee shall also have jurisdiction over all ordinances, orders, resolutions and matters affecting public utilities with the exception of those matters over which jurisdiction is conferred herein upon the Committee on Transportation and Public Way. The Committee on Ethics and Government Oversight shall have jurisdiction over matters concerning the ethical operation of City government and responsibility for the enforcement of Chapter 2-156 of the Municipal Code of Chicago. The Committee may hold hearings related to ethical governance of the City. The Committee also has jurisdiction to review, and may hold community hearings regarding, reports and audits issued by the Inspector General.
