### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Title 9, Chapter 64, of the Municipal Code of Chicago, the following

locations are hereby designated as traffic lane - tow/away zones, between the limits and during the

times specified, standing or parking of any vehicle shall be considered a definite hazard to the normal

movement of traffic:

#### WARD TOW ZONES:

- 1 N. Ashland Avenue (west side) from a point 68 feet south of W. Pierce Avenue to a point 22 feet south thereof; 15 Minute Standing Zone, must use flashing lights, Tow Zone after 15 Minutes, 11:00AM to 10:00PM, Monday through Saturday and 3:00PM to 10:00PM Sundays - 12-00130518 [O2011-10157]
- 1 W. Division Street (north side) from a point 80 feet east of N. Wood Street to a point 20 feet east thereof; 15 Minute Standing Zone, use flashing lights, Tow Zone after 15 Minutes, 6:00AM to 10:00PM, Monday through Sunday 12-00130578 [02011-10101]
- 2 W. Taylor Street (north side) from a point 100 feet west of S. Laflin Street to a point 25 feet west thereof: 15 Minute Standing Zone, 10:00AM to 12:00AM, All Days - 11-04316348 [02012-312]
