SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-1 Community Shopping District symbols and indications as shown on Map No. 5-1 in area bound by

A line 246 feet East of and parallel to North California Avenue, the public alley next North East of West Armitage Avenue, a line 296 feet East of and parallel to North California Avenue, West Armitage Avenue. to those of a B2-3 Neighborhood Mixed-Use District.

SECTION 2. This ordinance takes effect after its passage and approval.

#### NARRATIVE

While Armitage is usually a commercial street this section of Armitage is mostly residential. B2-3 Zoning will allow residential units on the ground floor which will fit right into this part of the neighborhood. The applicant seeks to build a 9,985 sq. ft. 4 story (49.7' in height), 8 residential dwelling unit brick building with basement, 8 parking spaces and no commercial space. The building has been set back off the front lot line to create additional green space and give the building a residential feel. The parking has been arranged to maximize green space in the rear yard and the developer has agreed to use recycled materials and energy
