West 43 <sup>rd</sup> Street: a line 71 feet east of and parallel to South Union Avenue; the alley next south of and parallel to West 43 <sup>rd</sup> Street; And South Union Avenue,

to those of a B2-1 Neighborhood Mixed-Use District and a corresponding uses district is herby established in the area described.
