### ***BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:***

SECTION L Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the RS-2 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 10-F in the area bounded by

West 43<sup>rd</sup> Street: a line 71 feet east of and parallel to South Union Avenue; the alley next south of and parallel to West 43<sup>rd</sup> Street; And South Union Avenue,

to those of a B2-1 Neighborhood Mixed-Use District and a corresponding uses district is hereby established in the area described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
