### **ORDINANCE**

WHEREAS, the City of Chicago (the "City"), a home rule unit of government under Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, has heretofore found and does hereby find that there exists within the City a serious shortage of decent, safe and sanitary rental housing available to persons of low and moderate income; and

WHEREAS, the City has determined that the continuance of a shortage of affordable rental housing is harmful to the health, prosperity, economic stability and general welfare of the City; and

WHEREAS, the City has programmed Community Development Block Grant funds (the "Multi-Program Funds") for its Multi-Family Loan Program (the "Multi-Program") wherein acquisition and rehabilitation loans are made available to owners of rental properties containing five or more dwelling units located in low- and moderate-income areas, and the Multi-Program is administered by the City's Department of Housing and Economic Development ("DHED"); and

WHEREAS, pursuant to an ordinance adopted on March 10, 1999, published in the Journal of Proceedings of the City Council of the City for such date at pages 90121-90126, DHED made a loan on or about December 6, 2000, in the principal amount of \$539,315 (the "Loan"), funded from Multi-Program Funds, to St. Edmund's Manor Limited Partnership, an Illinois limited partnership (the "Borrower") of which St. Edmund's Manor, Inc., an Illinois corporation is its general partner (the "General Partner"), for the acquisition and rehabilitation of a certain apartment building located at 5947-5959 South Indiana Avenue, 208-214 East 60<sup>th</sup> Street and 5956 South Prairie Avenue in Chicago, Illinois 60637 and of 31 dwelling units contained therein (the "Property"); and

WHEREAS, repayment of the Loan was secured by, among other things, a second mortgage on the Property in favor of the City (the "City Mortgage"); and

WHEREAS, the City Mortgage was junior to a mortgage made by the Borrower in favor of PFC Corporation, a Delaware corporation, securing a loan in the principal amount of \$740,300 (the "Senior Loan") to the Borrower in connection with the rehabilitation of the Property; and

WHEREAS, the Borrower has met with certain financial difficulties in the operation of the Property, and has requested that DHED approve a proposed restructuring of the Loan; and

WHEREAS, DHED has approved a restructuring of the Loan in a manner which (1) shall not change the identity of the Borrower, (2) shall not change the principal amount of the Loan, (3) shall not change the interest rate on the Loan, (4) shall extend the maturity date of the Loan, and (5) may permit the City Mortgage to be subordinated to one or more liens securing indebtedness senior to the Loan in addition to or in replacement of the Senior Loan (collectively, the "Restructuring"); now, therefore,

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

SECTION 1. The above recitals are expressly incorporated in and made a part of this ordinance as though fully set forth herein.

SECTION 2. The Commissioner of DHED (the "Commissioner") and a designee of the Commissioner are each hereby authorized, subject to approval by the Corporation Counsel, to enter into and execute such agreements and instruments, and perform any and all acts as shall be necessary or advisable in connection with the Restructuring. The Commissioner is hereby authorized, subject to the approval of the Corporation Counsel, to negotiate any and all terms and provisions in connection with the Restructuring. The Commissioner and a designee of the Commissioner are each hereby further authorized, subject to approval by the Corporation Counsel, to enter and execute such agreements and instruments and perform any and all acts as shall be necessary or advisable, and to negotiate any and all terms and provisions in connection with any future restructuring of the Loan which do not substantially modify the terms of the Restructuring.

SECTION 3. Notwithstanding anything to the contrary contained in the Municipal Code of Chicago or any other ordinance or mayoral executive order, no parties other than the borrower as of the date following the date of the closing of the transaction completed in connection with the Restructuring (the "Borrower"), any direct owners in excess of 7.5% of the Borrower which have changed in connection with the Restructuring, and all legal entities who constitute the direct or indirect controlling parties of the Borrower (as determined by the Corporation Counsel), shall be required to provide to the City the document commonly known as the "Economic Disclosure Statement and Affidavit" (or any successor to such document) in connection with any transaction completed in connection with the Restructuring.

SECTION 4. To the extent that any ordinance, resolution, rule, order or provision of the Municipal Code of Chicago, or part thereof, is in conflict with the provisions of this ordinance, the provisions of this ordinance shall control. If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any of the other provisions of this ordinance.

SECTION 5. This ordinance shall be effective as of the date of its passage and approval.
