#### **ORDINANCE**

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The City Council finds that the areas described in Sections 2 through 4 of this ordinance are adversely affected by the over-concentration of businesses licensed to sell alcoholic liquor within and near the areas.

SECTION 2. Section 4-60-022 of the Municipal Code of Chicago is hereby amended by inserting the underscored language as new subsections 4-60-022 (44.1) through 4-60-022 (44.5), as follows:

# 4-60-022 Restrictions On Additional Licenses.

Subject to the provisions of subsection 4-60-021 (c), no additional license shall be issued for the sale of alcoholic liquor, for consumption on the premises within the following areas:

- 1) <u>On Clark Street, from Fletcher Street to Buckingham Place.</u>
- 2) <u>On Belmont Avenue, from Clark Street to Sheffield Avenue.</u>
- 3) On Belmont Avenue, from Sheffield Avenue to Seminary Avenue.
- 4) On Belmont Avenue, from Seminary Avenue to Racine Avenue.
- 5) On Sheffield Avenue, from Barry Avenue to School Street.

SECTION 3. Section 4-60-023 of the Municipal Code of Chicago is hereby amended by inserting the underscored language as new subsections 4-60-023 (44.1) through 4-60-023 (44.5), as follows:

# 4-60-023 Restrictions on additional package goods licenses.

Subject to the provisions of subsection 4-60-021 (c), no additional package goods license shall be issued for any premises located within the following areas:

(Omitted text is unaffected by this ordinance)

- 1) On Clark Street, from Fletcher Street to Buckingham Place.
- 2) On Belmont Avenue, from Clark Street to Sheffield Avenue.
- 3) On Belmont Avenue, from Sheffield Avenue to Seminary Avenue.
- 4) <u>On Belmont Avenue, from Seminary Avenue to Racine Avenue.</u>
- 5) On Sheffield Avenue, from Barry Avenue to School Street.

SECTION 4. Section 4-60-023 of the Municipal Code of Chicago is hereby amended by deleting the language struck through and inserting the underscored language, as follows:

### 4-60-023 Restrictions on additional package goods licenses.

Subject to the provisions of subsection 4-60-021 (c), no additional package goods license shall be issued for any premises located within the following areas:
