ORDINANCE

CARMICHAEL'S CHICAGO STEAK HSE Acct. No.

18872 - 1 Permit No. 1103413

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to CARMICHAEL'S CHICAGO STEAK HSE, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, four (4) Awning(s) projecting over the public right-of-way adjacent to its premises known as 1052 W. Monroe St..

Said Awning(s) at WEST MONROE measure(s):

One (1) at fourteen point five (14.5) feet in length, and two (2) feet in width for a total of twenty-nine (29) square feet. One (1) at thirteen point eight three (13.83) feet in length, and two (2) feet in width for a total of twenty-seven point six six (27.66) square feet.

One (1) at fifteen point eight three (15.83) feet in length, and thirteen (13) feet in width for a total of two hundred five point seven nine (205.79) square feet.

One (1) at fifteen point eight three (15.83) feet in length, and two (2) feet in width for a total of thirty-one point six six (31.66) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1103413 herein granted the sum of one hundred seventy-five (\$175.00) per annum in advance.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.
