ORDINANCE
BOARD OF TRUSTEES UNIVERSITY OF ILLINOIS Acct. No.
309115-3 Permit No: 1103194

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to BOARD OF TRUSTEES UNIVERSITY OF ILLINOIS, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use two (2) steam Tunnel(s) under the public right-of-way adjacent to its premises known as 1220 S. Wood St..

Said steam Tunnel at W. Roosevelt Road measure(s):

One (1) at two hundred fifty-seven (257) feet in length, and four point four (4.4) feet in width for a total of one thousand one hundred thirty point eight (1130.8) square feet.

Said steam Tunnel at S. Wood measure(s):

One (1) at sixty-six (06) feet in length, and four point five (4.5) feet in width for a total of two hundred ninety-seven (297) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1103194 herein granted the sum of eight hundred (\$800.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs

associated with damage, relocation or removal of private property caused by the City performing work in the public way.
