ORDINANCE ONE STOP FOOD ANDLIQUORS Acct. No. 4135-1 Permit No. 1103284

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to ONE STOP FOOD ANDLIQUORS, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Bay Window(s) projecting over the public right-of-way adjacent to its premises known as 3456 S. Western Ave..

Said Bay Window(s) at S. Western & W. 35th Street measure(s):

One (1) at fifteen point one six (15.16) feet in length, and one point four two (1.42) foot in width for a total of twenty-one point five three (21.53) square feet.

Said Bay Window(s) at W. 35th Street measure(s):

One (1) at eleven point one six (11.16) feet in length, and two point five eight (2.58) feet in width for a total of twenty-eight point seven nine (28.79) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1103284 herein granted the sum of one hundred fifty (\$150.00) per annum in advance.

A 25% penalty will be added for payments received after due date.
