WEST BALMORAL AVENUE; A LINE 226.98 FEET WEST OF AND PARALLEL TO NORTH DAMEN AVENUE; THE PUBLIC ALLEY NEXT SOUTH OF AND PARALLEL TO WEST BALMORAL AVENUE; AND, A LINE 259.98 FEET WEST OF AND PARALLEL TO NORTH DAMEN AVENUE.

To those of an RT 3.5 Residential Two-Flat, Townhouse and Multi-Unit District, and a corresponding use district is hereby established in the area above described.
