BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1.

West Medill Avenue; a line 151.25 feet West of and parallel to North Campbell Avenue; the public alley next south of and parallel to West Medill Avenue; a line 178.25 feet West of and parallel to North Campbell Avenue.
