ORDINANCE
JOS. CACCIATORE REAL ESTATE Acct. No.
80770 - 4 Permit No. 1094713

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to JOS. CACCIATORE REAL ESTATE, upon the terms and subject to the conditions of this ordinance to maintain and use a portion of the public right-of-way for Occupation of Space (Parking) adjacent to its premises known as 2152 S. Canalport Ave..

Said Occupation of Space shall be used for parking along South Sangamon Street between Canalport Avenue and West 21st Street. . Occupation of space shall measure one hundred ninety-one point eight eight (191.88) feet in length, and fifty-nine point seven five (59.75) feet in width for a total of eleven thousand four hundred sixty-four point eight three (11464.83) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development, Department of Transportation (Division of Project Development), and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1094713 herein granted the sum of six thousand eighty-one (\$6,081.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after Date of Passage.
