BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B1 -2 Neighborhood Shopping District symbols and indications as shown on Map No. 22-B in area bound by

The alley next West and parallel to South Commercial Avenue, a line 130 feet North and parallel to East 90th Street, South Commercial Avenue a line 83 feet North and parallel to East 90th Street.
