ORDINANCE

RIVER EAST PLAZA, L.L.C. Acct. No.

82028 - 1 Permit No. 1104807

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to RIVER EAST PLAZA, L.L.C, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Vault(s) under the public right -of-way adjacent to its premises known as 401 E. Illinois St..

Vault #1 shall run under the along the south side of East Illinois Street at a point one hundred thirty (130) feet west of North MC Clurg Court. Existing vault run for a total length of eleven (11) feet west, at a width of five (5) feet six (6) inches and shall be eight (8) feet in depth.

Vault #2 shall run under and along the south side of East Illinois Street at a point five hundred five (505) feet west of North McClurg Court. Existing vault shall run for a total length eleven (11) feet, at a width of five (5) feet, six (6) inches and shall be eight (8) feet in depth.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1104807 herein granted the sum of eight hundred (\$800.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs
