ORDINANCE SHERWIN PACKER Acct. No. 379017-1

#### Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to SHERWIN PACKER, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Cornice(s) projecting over the public right-of-way adjacent to its premises known as 1064-1070 W. Berwyn Ave..

Said Cornice(s) at W. Brywyn measure(s):

One (1) at thirty-six (36) feet in length, and one point eight three (1.83) foot in width for a total of sixty-five point eight eight (65.88) square feet. Existing cornice is twelve (12) feet eleven (11) inches above grade level.

One (1) at thirty-six (36) feet in length, and one point eight three (1.83) foot in width for a total of sixty-five point eight eight (65.88) square feet. Existing cornice is forty-four (44) feet above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1104915 herein granted the sum of eight hundred (\$800.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs
