ORDINANCE DECLAN'S IRISH PUB Acct. No. 18220-1 Permit No. 1104869

Be It Ordained by the City Council of the City of Chicago:

Permission and authority are hereby given and granted to DECLAN'S IRISH PUB upon the terms and subject to the conditions of this ordinance, to maintain and use a portion of the public right of way for a sidewalk cafe adjacent to its premises located at 1240 N. This grant of privilege #1104869 for a sidewalk cafe shall be subject to the provisions of Section 10-28-900 though 10-28-995 of the Municipal Code of Chicago and the directions of the Commissioner

of Department of Business Affairs and Consumer Protection, the Commissioner of Streets and Sanitation, and the Commissioner of Transportation.
