North Bell Avenue, West Chase Avenue, the alley next East and parallel to North Bell Avenue, a line 50 feet South and parallel to West Chase Avenue. to those of a RM-4.5 Residential Multi-Unit District.

SECTION 2. This ordinance takes effect after its passage and approval.


