AMEND TAXICAB STAND #732

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO

Section 1. That an ordinance passed by the City Council on February 5, 1998 page 62188 and 62190 of the Journal of Proceedings which reads, west side of South Wabash Avenue, from a point 20 feet south of East Madison Street to a point 60 feet south thereof, for three vehicles - tow-away zone, in designated area, be and the same is hereby amended by striking there from the following:

from a point 20 feet south of East Madison Street to a point 60 feet south thereof, for three vehicles and inserting in lieu thereof

from a point 60 feet south of East Madison Street to a point 20 feet south thereof, for one vehicle, Taxicab Stand #732

Section 2. This ordinance shall take effect and be in force hereinafter its passage and publication.

SECTION 1. That the Commissioner of Transportation is hereby authorized and directed to establish Taxicab Stand Number 732 on South Wabash Avenue (west side) from a point twenty (2.0) feet south of East Madison Street, to a point sixty (60) feet south thereof, for three (3) vehicles - tow-zone.
