Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to MACERICH MANAGEMENT, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Kiosk(s) on the public right-of -way adjacent to its premises known as 43 E. Ohio St.

Said Kiosk(s) at E. Ohio Street measure(s):

One (1) at two point one seven (2.17) feet in length, and eight point five (8.5) feet in width foratotal of eighteen point four five (18.45) square feet.

Said Kiosk(s) at N. Wabash Avenue measure(s):

One (1) at two point one seven (2.17) feet in length, and eight point five (8.5) feet in width for a total of eighteen point four five (18.45) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development) and Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1105904 herein granted the sum of eight hundred (\$800.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs
