ORDINANCE

16TH & PULASKI CURRENCY EXCHANGE Acct.

No. 243071 - 1 Permit No. 1106734

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to 16TH & PULASKI CURRENCY EXCHANGE, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, four (4) Security Camera(s) projecting over the public right-of-way for security purposes adjacent to its premises known as 1559 S. Pulaski Rd..

Said Security Camera(s) at S. Pulaski Road measure(s):

Two (2) at one point five (1.5) foot in length, one point five (1.5) foot in width and twelve (12) feet above grade level. Said

Security Camera(s) at W. 16th Street measure(s):

Two (2) at one point five (1.5) foot in length, one point five (1.5) foot in width and twelve (12) feet above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1106734 herein granted the sum of zero (\$.00) per annum in advance.

A 25% penalty will be added for payments received after due date.
