EXEMPTION OF INSPIRATION CORPORATION FROM PAYMENT OF CITY PERMIT, LICENSE AND INSPECTION FEES FOR PERIOD ENDING June 8, 2015.

Be // Ordained by the City Council of the City oj Chicago:

SECTION 1. That the Commissioner of Buildings, the Commissioner of Transportation, the Commissioner of Streets, and Sanitation, the Commissioner of Sewers, the Commissioner of Water, the Commissioner of Fire, the Director of Business Affairs and Licensing, and the Director of Revenue are hereby directed to issue all necessary permits, all on-site water/sewer inspection fees and all water/sewer plan review fees, free of charge, notwithstanding other ordinances of the City of Chicago to the contrary, to Inspiration Corporation, a not-for-profit Illinois corporation, related to the erection and maintenance of building(s) and fuel storage facilities at:

806 E. 64th Street Chicago, IL 60637

Said building(s) and all appurtenances thereto shall be used exclusively for charitable purposes and shall not be leased or otherwise used with a view-to profit, and the work thereon shall be done in accordance with plans submitted and all of the appropriate provisions of the Municipal Code of the City of Chicago and departmental requirements of various departments of the City of Chicago, and said building(s) and all appurtenances thereto shall be constructed and maintained so that they shall comply in all respects with the requirements of the appropriate provisions of the Municipal Code of the City

SECTION 2. The Inspiration Corporation d/b/a The Living Room Cafe, a not-for-profit Illinois corporation located at 806 E. 64th Street, engaged in cultural, educational and related activities, shall be exempt from the payment of city license fees and shall be entided to the cancellation of warrants for the collection of inspection fees.

SECTION 3. The Inspiration Corporation d/b/a/ The Living Room Cafe shall be entitled to a refund of city fees which it has paid and from which it is exempt pursuant to Sections 1 and 2 of this ordinance.

SECTION 4. This ordinance shall be in force for a period of two (2) year(s) but in no event beyond June 8, 2015.
