ORDINANCE  
JEWEL FOOD STORE #3368 Acct. No.  
259 - 51 Permit No. 1107397

*Be It Ordained by the City Council of the City of Chicago:*

SECTION 1. Permission and authority are hereby given and granted to JEWEL FOOD STORE #3368, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, twelve (12) Canopy(s) projecting over the public right-of-way adjacent to its premises known as 550 N. State St..

Said Canopy(s) at N. STATE measure(s):

Four (4) at twenty-one point one (21.1) feet in length, and four (4) feet in width for a total of three hundred thirty-seven point six (337.6) square feet.

Said Canopy(s) at N. STATE ST measure(s):

One (1) at ten point nine (10.9) feet in length, and four (4) feet in width for a total of forty-three point six (43.6) square feet.

Said Canopy(s) at N. STATE ST measure(s):

One (1) at ten point five (10.5) feet in length, and four (4) feet in width for a total of forty-two (42) square feet. Said

Canopy(s) at N. STATE ST measure(s):

Two (2) at sixteen point four (16.4) feet in length, and four (4) feet in width for a total of one hundred thirty-one point two (131.2) square feet.

Said Canopy(s) at N. STATE ST measure(s):

One (1) at twelve (12) feet in length, and four (4) feet in width for a total of forty-eight (48) square feet. Said

Canopy(s) at N. STATE measure(s):

Two (2) at sixteen point one (16.1) feet in length, and four (4) feet in width for a total of one hundred twenty-eight point eight (128.8) square feet.

Said Canopy(s) at N. STATE ST measure(s):

One (1) at twenty-one (21) feet in length, and four (4) feet in width for a total of eighty-four (84) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1107397 herein granted the sum of one hundred seventy-five (\$175.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after 06/29/2013.
