ORDINANCE

REHABILITATION INSTITUTE OF CHICAGO Acct.

No. 6323 - 5 Permit No. 1107365

Be It Ordained by the City Council ofthe City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to REHABILITATION INSTITUTE OF CHICAGO, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use three (3) Water Line (s) under the public right-of-way adjacent to its premises known as 630 N. Mcclurg Ct..

Said Water Line(s) at E. Erie measure(s):

Two (2) at seventy-two (72) feet in length, and twenty-two (22) feet in width for a total of three thousand one hundred sixty-eight (3168) square feet. Said water lines shall be approximately seven (7) feet below grade level

One (1) at twenty-nine (29) feet in length, and five (5) feet in width for a total of one hundred forty-five (145) square feet. Said water line shall be approximately seven (7) feet below grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Office of Underground Coordination) and Department of Water Management.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1107365 herein granted the sum of seven thousand twenty-nine (\$7,029.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.
