### ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-3 Community Shopping District, B3-2 Community Shopping District and RM5 Multi-Unit District symbols and indications as shown on Map No. 10-E in the area bounded by:

South Wabash Avenue, East 47<sup>th</sup> Street, South Michigan Avenue; a line 175.06' south of and parallel to the south line of East 46<sup>th</sup> Street; a line 110.00' west of and parallel to the west line of South Michigan Avenue; a line 60.00' south of and parallel to the south line of East 46<sup>th</sup> Street; a line 161.00' west of and parallel to the west line of South Michigan Avenue; and East 46<sup>th</sup> Street

to those of a B2-3 Neighborhood Mixed-Use District.

SECTION 2. This ordinance takes effect after its passage and approval.

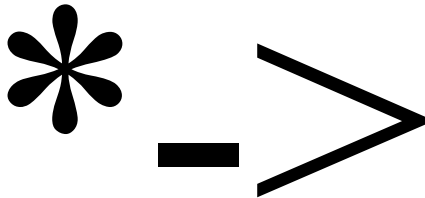
