ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The City Council finds that the areas described in Sections 2 through 36 of this ordinance are adversely affected by the over-concentration of businesses licensed to sell alcoholic liquor within and near the areas.

SECTION 2. Section 4-60-022 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-022 (35.5), which was previously deleted as shown in the Journal of Proceedings of February 11, 2009 at page 55009, with the following underscored text:

4-60-022 (35.5) On West Belmont Avenue, from North Kimball to North Central Park Avenue.

SECTION 3. Section 4-60-022 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-022 (35.8), which was previously deleted as shown in the Journal of Proceedings of July 25, 2012 at page 31346, with the following underscored text:

<u>4-60-022 (35.8)</u> On West Diversey Avenue, from North California Avenue to North Sacramento Avenue. SECTION 4. Section 4-60-022 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-022 (35.18), which was previously deleted as shown in the Journal of Proceedings of February 6, 2008 at page 20712, with the following underscored text:

<u>4-60-022 (35.18)</u> On West Armitage Avenue, from North Sacramento Avenue to North Kedzie Avenue.

SECTION 5. Section 4-60-022 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-022 (35.24), which was previously deleted as shown in the Journal of Proceedings of March 14, 2007 at page 99834, with the following underscored text:

<u>4-60-022 (35.24)</u> On North Milwaukee Avenue, from North California Avenue to North Sacramento Avenue.

SECTION 6. Section 4-60-022 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-022 (35.25), which was previously deleted as shown in the Journal of Proceedings of November 17, 2010 at page 108062, with the following underscored text:

<u>4-60-022 (35.25)</u> On North Milwaukee Avenue, from North Sacramento Avenue to West Logan Boulevard.

SECTION 7. Section 4-60-022 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-022 (35.26), which was previously deleted as shown in the Journal of Proceedings of November 19, 2008 at page 49401, with the following underscored text:

4-60-022 (35.26) On North Milwaukee Avenue, from West Logan Boulevard to North Kimball Avenue.

SECTION 8. Section 4-60-022 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-022 (35.31), which was previously deleted as shown in the Journal of Proceedings of October 8, 2008 at page 40069, with the following underscored text:

<u>4-60-022 (35.31) On North California Avenue, from West Palmer Street to West Fullerton Avenue.</u>

SECTION 9. Section 4-60-022 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-022 (35.36), which was previously deleted as shown in the Journal of Proceedings of October 8, 2008 at page 40070, with the following underscored text:

4-60-022 (35.36) On the west side of North Kedzie Avenue, from West Belden Avenue to West Altgeld Street; and on both sides of North Kedzie Avenue, from West Altgeld Street to the south line of West Wrightwood/Logan Boulevard.

SECTION 10. Section 4-60-022 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-022 (35.37), which was previously deleted as shown in the Journal of Proceedings of July 29, 2009 at page 67875, with the following underscored text:

<u>4-60-022 (35.37)</u> On North Kedzie Avenue, from the north line of West Wrightwood/West Logan Boulevard to West Diversey Avenue. SECTION 11. Section 4-60-022 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-022 (25.38), which was previously deleted as shown in the Journal of Proceedings of October 13, 2007 at page 11441, with the following underscored text:

4-60-022 (35.38) On North Kedzie Avenue, from West Diversey Avenue to West Wellington Avenue.

SECTION 12. Section 4-60-022 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-022 (35.40), which was previously deleted as shown in the Journal of Proceedings of December 14, 2011 at page 17741, with the following underscored text:

<u>4-60-022 (35.40)</u> On the west side of North Kedzie Avenue, from West Belmont Avenue to Elston Avenue.

SECTION 13. Section 4-60-022 of the Municipal Code of Chicago is hereby amended by replacing subsections 4-60-022 (35.55), 4-60-022 (35.56) and 4-60-023 (35.57) which were previously deleted as shown in the Journal of Proceedings of April 22, 2009 at page 58581, with the following underscored text:

<u>4-60-022 (35.55) On the north side of Belmont Avenue, from Central Park Avenue to Kimball Avenue.</u>

4-60-022 (35.56)On the north side of Belmont Avenue, from Kimball Avenue to Kedzie Avenue.4-60-022 (35.57)On Kimball Avenue, from Grace Street to Addison Street.

SECTION 14. Section 4-60-023 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-023 (35.1), which was previously deleted as shown in the Journal of Proceedings of December 13, 2007 at page 95131, with the following underscored text:

<u>4-60-023 (35.1)</u> On West Irving Park Road, on the south side only from North Christiana Avenue to North Bernard Avenue, on both sides of West Irving Park Road, from North Bernard Avenue to North St. Louis Avenue to North Drake Avenue.

SECTION 15. Section 4-60-023 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-023 (35.3), which was previously deleted as shown in the Journal of Proceedings of January 9, 2008 at page 18928, with the following underscored text:

<u>4-60-023 (35.3)</u> On West Addison Street, from North Kimball Avenue to North Lawndale Avenue.

SECTION 16. Section 4-60-023 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-023 (35.4), which was previously deleted as shown in the Journal of Proceedings of May 4, 2011 at page 117716, with the following underscored text:

<u>4-60-023 (35.4) On West Belmont Avenue, from North Kedzie Avenue to North Kimball Avenue.</u>

SECTION 17. Section 4-60-023 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-023 (35.5), which was previously deleted as shown in the Journal of Proceedings of March 10, 2010 at page 86567, with the following underscored text:

<u>4-60-023 (35.5) On West Belmont Avenue, from North Kimball to North Central Park Avenue.</u>

SECTION 18. Section 4-60-023 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-023 (35.6), which was previously deleted as shown in the Journal of Proceedings of September 5, 2007 at page 6874, with the following underscored text:

<u>4-60-023 (35.6)</u> On West Belmont Avenue, from North Central Park Avenue to North Lawndale Avenue, and on the south side of West Belmont Avenue, from North Lawndale Avenue to North Ridgeway Avenue.

SECTION 19. Section 4-60-023 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-023 (35.14), which was previously deleted as shown in the Journal of Proceedings of March 9, 2005 at page 44074, with the following underscored text:

<u>4-60-023 (35.14)</u> On West Fullerton Avenue, from North Sacramento Avenue to North Albany Avenue; and on North Albany Avenue from West Medill Avenue to West Altgeld Street.

SECTION 20. Section 4-60-023 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-023 (35.15), which was previously deleted as shown in the Journal of Proceedings of September 29, 2009 at page 67878, with the following underscored text:

<u>4-60-023 (35.15) On West Fullerton Avenue, from North Kedzie to North Kimball Avenue.</u>

SECTION 21. Section 4-60-023 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-023 (35.17), which was previously deleted as shown in the Journal of Proceedings of March 10, 2004 at page 19858, with the following underscored text:

<u>4-60-023 (35.17)</u> On West Armitage Avenue, from North California Avenue to North Sacramento Avenue.

SECTION 22. Section 4-60-023 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-023 (35.18), which was previously deleted as shown in the Journal of Proceedings of March 10, 2010 at page 86569, with the following underscored text:

<u>4-60-023 (35.18)</u> On West Armitage Avenue, from North Sacramento Avenue to North Kedzie Avenue.

SECTION 23. Section 4-60-023 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-023 (35.19), which was previously deleted as shown in the Journal of Proceedings of May 5, 2004 at page 22753, with the following underscored text:

<u>4-60-023 (35.19)</u> On West Armitage Avenue, from North Kedzie Avenue to North Kimball Avenue.

SECTION 24. Section 4-60-023 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-023 (35.22), which was previously deleted as shown in the Journal of Proceedings of February 7, 2007 at page 98127, with the following underscored text:

<u>4-60-023 (35.22)</u> On the southwest side of North Elston Avenue, from North Kedzie Avenue to North Christania Avenue; and on both sides of North Elston Avenue, from North Christiana Avenue to West Grace Street.

SECTION 25. Section 4-60-023 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-023 (35.24), which was previously deleted as shown in the Journal of Proceedings of October 6, 2005 at page 58183, with the following underscored text:

<u>4-60-023 (35.24)</u> On North Milwaukee Avenue, from North California Avenue to North Sacramento Avenue.

SECTION 26. Section 4-60-023 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-023 (35.26), which was previously deleted as shown in the Journal of Proceedings of April 6, 2005 at page 45953, with the following underscored text:

On North Milwaukee Avenue, from West Logan Boulevard to North Kimball Avenue.

SECTION 27. Section 4-60-023 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-023 (35.29), which was previously deleted as shown in the Journal of Proceedings of February 11, 2009 at page 55012, with the following underscored text:

<u>4-60-023 (35.29)</u> On North California Avenue, from West Bloomingdale Avenue to West Armitage Avenue.

SECTION 28. Section 4-60-023 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-023 (35.30), which was previously deleted as shown in the Journal of Proceedings of October 6, 2005 at page 58185, with the following underscored text:

4-60-023 (35.30) On North California Avenue, from West Armitage Avenue to West Palmer Street.

SECTION 29. Section 4-60-023 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-023 (35.32), which was previously deleted as shown in the Journal of Proceedings of June 29, 2005 at page 52117, with the following underscored text:

<u>4-60-023 (35.32)</u> On North California Avenue, from West Fullerton Avenue to West Logan Boulevard.

SECTION 30. Section 4-60-023 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-023 (35.33) and 4-60-023 (35.52), which were previously deleted as shown in the Journal of Proceedings of March 10, 2010 at page 86570, with the following underscored text:

4-60-023 (35.33)On North California Avenue, from West Logan Boulevard to North Avondale Avenue.4-60-023 (35.52)On California Avenue, from Diversey Avenue to Logan Boulevard.

SECTION 31. Section 4-60-023 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-023 (35.37), which was previously deleted as shown in the Journal of Proceedings of March 9, 2005 at page 44075, with the following underscored text:

<u>4-60-023 (35.37)</u> On North Kedzie Avenue, from the north line of West Wrightwood/West Logan Boulevard to West Diversey Avenue.

SECTION 32. Section 4-60-023 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-023 (35.40), which was previously deleted as shown in the Journal of Proceedings of November 2, 2011 at page 11895, with the following underscored text:

<u>4-60-023 (35.40)</u> On the west side of North Kedzie Avenue, from West Belmont Avenue to Elston Avenue.

SECTION 33. Section 4-60-023 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-023 (35.41), which was previously deleted as shown in the Journal of Proceedings of February 7, 2007 at page 98128, with the following underscored text:

4-60-023 (35.41) On North Kimball Avenue, from West Courtland Street to West Dickens Avenue.

SECTION 34. Section 4-60-023 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-023 (35.46), which was previously deleted as shown in the Journal of Proceedings of October 8, 2008 at page 40073, with the following underscored text:

<u>4-60-023 (35.46)</u> On North Kimball Avenue, from West Belmont Avenue to the Chicago & Northwestern Railroad right-of-way.

SECTION 35. Section 4-60-023 of the Municipal Code of Chicago is hereby amended by replacing subsection 4-60-023 (35.55), which was previously deleted as shown in the Journal of Proceedings of April 22, 2009 at page 58581, with the following underscored text:

<u>4-60-023 (35.55)</u> On Kimball Avenue, from Grace Street to Addison Street.

SECTION 36. This ordinance shall be in full force and effect from and after its passage and publication.
