#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the B3-5 Community Shopping District symbols and indications as shown on Map No. 14-D in the area bounded by

East 55<sup>th</sup> Street; South Lake Park Avenue; a line 150.75 feet south of and parallel to East 55<sup>th</sup> Street; and South Harper Avenue,

to those of a C2-5 Motor Vehicle-Related Commercial District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

The building currently contains retail units at grade level (first floor) and office units on the second and third floors, respectively. The building also contains an interior parking area (garage) on the first floor (5,680 sq. ft.) and second floor (9,818 sq. ft.), as well as in the lower (basement) level (18,563 sq. ft.).
- 12. Reason for rezoning the property: The Applicant is seeking a zoning amendment in order to locate and establish a hand car wash facility within the lower (basement) level of the existing building at the subject site.
