**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1.**

**Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols as shown on Map No. 9-K in the area bounded by:**

**A line 224.15 feet North of and parallel to West School Street; the public alley next East of and parallel to North Keating Avenue; a line 186.65 feet North of and parallel to West School Street; North Keating Avenue.**

**To those of an RT3.5, Residential Two-Flat, Townhouse and Multi-Unit District SECTION 2.**
