SUBSTITUTE ORDINANCE

WHEREAS, the Annual Appropriation Ordinance for the year 2014 of the City of Chicago (the "City") contains estimates of revenues receivable as grants from agencies of the state and federal governments and public and private agencies; and

WHEREAS, in accordance with Section 8 of the Annual Appropriation Ordinance, the heads of various departments and agencies of the City have applied to agencies of the state and federal governments and public and private agencies for grants to the City for various purposes; and

WHEREAS, the City through its Department of Innovation and Technology has been awarded private carryover grant funds in the amount of \$1,000,000 by Bloomberg Philanthropies which shall be used for the Mayors Challenge Grant Smart Data Platform Program; and

WHEREAS, the City through its Department of Family and Support Services has been awarded federal grant funds in the amount of in the amount of \$123,000 by the Illinois Department on Aging which shall be used for the Medicare Improvements for Patients and Providers Act Program; and

WHEREAS, the City through its Office of Emergency Management & Communications has been awarded state grant funds in the amount of \$10,000 by the Illinois Emergency Management Agency which shall be used for the Illinois Transportable Emergency Communications Systems Maintenance Program; now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The sum of \$1,133,000 not previously appropriated, representing increased grant awards is hereby appropriated from Fund 925 - Grant Funds for the year 2014. The Annual Appropriation Ordinance is hereby further amended by striking the words and figures and adding the words and figures indicated in the attached Exhibit A which is hereby made a part hereof.

SECTION 2. To the extent that any ordinance, resolution, rule, order or provision of the Municipal Code of Chicago, or part thereof, is in conflict with the provisions of this ordinance, the provisions of this ordinance.shall control. If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity of such section,
