ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the M3-3 Heavy Industry District symbols and indications as shown on Map No.5-H in the area bounded by

the alley next northeast of North Elston Avenue; the alley next east of and parallel to North Elston Avenue; a line 375 feet southeast of the intersection of West Fullerton Avenue and North Elston Avenue as measured along the northeasterly right-of-way line of North Elston and perpendicular thereto; North Elston Avenue; and a line 300 feet southeast of the intersection of West Fullerton Avenue and North Elston Avenue as measured along the northeasterly right-of-way line of North Elston Avenue and perpendicular thereto,

to those of a Cl-3 Neighborhood Commercial District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due

publication.

 The existing two-story building and one-story building will, both, be razed. The proposed zoning amendment will allow the Applicant to redevelop the site with a new two-story building (13.549.75 sq.ft.), which will be used for operating a children's day care facility. The proposed new building will contain interior (lower level) on-site parking for thirteen (13) vehicles and a roof top (open air) playground.
