## Be It Ordained by the City Council ofthe City of Chicago.

SECTION 1. Permission and authority are hereby given and granted to F \& R LIQUORS INC, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Awning(s) projecting over the public right-of-way adjacent to its premises known as 2129 S. ## Said Awning(s) at S. Halsted measure(s):

One (1) at nineteen point three (19.3) feet in length, and five point seven five (5.75) feet in width for a total of one hundred ten point nine eight (110.98) square feet.
One (1) at thirteen point five (13.5) feet in length, and five point seven five (5.75) feet in width for a total of seventy-seven point six three (77.63) square feet.
