ORDINANCE
GOLFTEC HALSTED ROW Acct. No.
288203 - 2 Permit No. 1109823

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to GOLFTEC HALSTED ROW, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use four (4) Awning(s) projecting over the public right-of-way adjacent to its premises known as 2847 N. Halsted St..

Said Awning(s) at N HALSTED ST measure(s):

Two (2) at sixteen point one seven (16.17) feet in length, and two (2) feet in width for a total of sixty-four point six eight (64.68) square feet.

One (1) at twenty-three point nine two (23.92) feet in length, and two (2) feet in width for a total of forty-seven point eight four (47.84) square feet.

One (1) at six (6) feet in length, and two (2) feet in width for a total of twelve (12) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1109823 herein granted the sum of one hundred seventy-five (\$175.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after Date of Passage.
