## Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to NORTHWESTERN MEMORIAL HOSPITAL, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, five (5) Drain Tile(s) under the public right-of-way adjacent to its premises known as 245 E. Chicago Ave..

Said Drain Tile(s) at Superior St (Building Drain Tile) measure(s):

One (1) at two hundred thirty-four point seven five (234.75) feet in length; and one (1) foot in width for a total of two hundred thirty-four point seven five (234.75) square feet.

Said Drain Tile(s) at Chicago Ave (Building Drain Tile) measure(s):

One (1) at two hundred thirty-four point zero eight (234.08) feet in length, and one (1) foot in width for a total of two hundred thirty-four point zero eight (234.08) square feet.

Said Drain Tile(s) at Superior St (Planter Drain Tile) measure(s):

One (1) at fifty (50) feet in length, and one (1) foot in width for a total of fifty (50) square feet. Said Drain

Tile(s) at Fairbanks Crt (Planter Drain Tile) measure(s):

One (1) at fifty (50) feet in length, and one (1) foot in width for a total of fifty (50) square feet. Said Drain

Tile(s) at Chicago Ave (Planter Drain Tile) measure(s):

One (1) at fifty (50) feet in length, and one (1) foot in width for a total of fifty (50) square feet.

Said privilege shall be constructed-in accordance with plans 'andrspecifications approved by the Department of

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1110062 herein granted the sum of two thousand three hundred seventy-six (\$2,376.00) per annum in advance.

A 25% penalty will be added for payments received after due date.
