### ORDINANCE

**ROYAL FURNISHINGS & NOVELTIES Acct. No.  
56761 -1 Permit No. 1110995**

*Be It Ordained by the City Council of the City of Chicago:*

**SECTION 1.** Permission and authority are hereby given and granted to **ROYAL FURNISHINGS & NOVELTIES**, upon the terms and subject to the conditions of this ordinance to maintain and use one (1) sign(s) projecting over the public right-of-way attached to its premises known as 235-237 W. 75th St..

**Said sign structure(s) measures as follows; along W. 75th Street:**

**One (1) at five point five (5.5) feet in length, three point five (3.5) feet in height and ten (10) feet above grade level.**

**The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.**

**Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development) and Zoning Department - Signs.**

**This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.**

**The grantee shall pay to the City of Chicago as compensation for the privilege #1110995 herein granted the sum of one hundred (\$100.00) per annum in advance.**

**A 25% penalty will be added for payments received after due date.**

**The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or**

replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after 11/19/2013.
