terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Security.

Said Security Camera(s) at W. Belmont Avenue measure(s): >!i', One (1) at four (4) feet in length, two point seven f ive (2.75) feet in width and fourteen point four two (14.42) feet above, grade level.

Said Security Camera(s) at N. Cicero Avenue measure(s):

One (1) at two (2) feet in length, one point five (1.5) foot in width and thirteen point six seven (13.67) feet above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1110999 herein granted the sum of zero (\$.00) per annum in advance.
