SECTION 1. Permission and authority are hereby given and granted to SALON NUEVAIMAGEN, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, one (1) Awning(s) projecting over the public right-of-way adjacent oits premises known as 5644 S. Kedzie Ave..

One (1) at twenty-three (23) feet in length, and two (2) feet in width for a total of f6rty.tsix-(46) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department-Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.
