SECTION 1. Permission and authority are hereby given and granted to Drybar, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, one (1) Wind Screen(s) on the public right-of-way adjacent to its premises known as 1611 N. Sheffield Ave.. . • n . ■

Said Wind Screen(s) at N Sheffield Ave measure(s): ; ! i ■■'■o. ti.
One (1) at seven point six seven (7.67) feet in length, and three (3) feet in width for a total of twenty-three point zero one (23.01) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1110956 herein granted the sum of four hundred (\$400.00) per annum in advance.

A 25% penalty will be added for payments received after due date.
