BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS3 Residential Single-Unit(Detached House) District symbols and indications as shown on Map No. 3-1 in the area bounded by

A line 25.90 feet north of and parallel to West Augusta Boulevard; North Mozart Street; West Augusta Boulevard; the public alley next east of and parallel to North Mozart Street

to those of a **RM5 Residential Multi-Unit District**

SECTION 2. This ordinance takes effect after its passage and approval.

Project description
This request is to rezone the lot at 1000 North Mozart in order to convert a storefront retail space to a dwelling unit.

The existing building is a three story masonry building with 5 dwelling units and 1 storefront. The building envelope will not be changed. We propose to change only the composition of the building from mixed use to all residential with 6 dwelling units.

- a) The proposed land use will be 6 dwelling units
- b) The Floor Area Ratio will remain 2.1
- c) The density (lot area per dwelling) will be 542 sq.ft. per dwelling unit.
- d) The amount of off-street parking will remain 1 space.

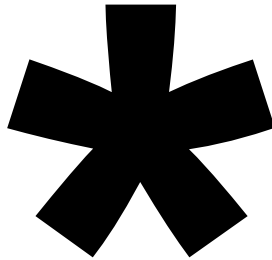

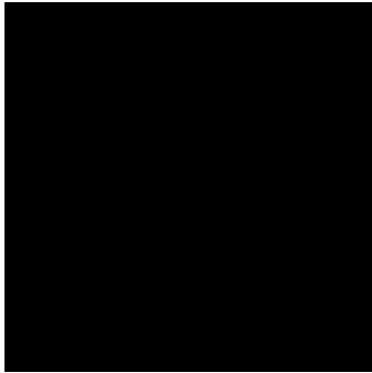
