#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the Ml-1 Limited Manufacturing/ Business Park District symbols and indications as shown on Map No.5-J in the area bounded by

West Bloomingdale Avenue; the alley next east of and parallel to North Kimball Avenue; a line 205.35 feet south of and parallel to West Bloomingdale Avenue; and North Kimball Avenue,

to those of a C1-2 Neighborhood Commercial District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

I, the undersigned, filed an application for a change in zoning from the Ml-1 Limited Manufacturing/Business Park District to the Cl-2 Neighborhood Commercial District, on behalf of the Applicant/Owner, C&R Real Estate Development, LLC, for the property located at 1757 North Kimball Avenue, Chicago, Illinois.

The applicant seeks a zoning amendment in order to allow additional commercial uses not permitted in the MI zoning district. The expansion of use is proposed for the existing 49,080 square foot 1 and 2 story brick building with 29 on-site parking spaces. The additional uses include general retail sales, restaurant over 4,000 square feet, food and beverage retail sales over 3,000 square feet, as well as other uses not currently permitted.
