Be It Ordained by the City Council of the City of Chicago, that the City Clerk be and she is hereby authorized to execute and deliver to the City of Chicago, a resolution of the City Council, to the effect that the City Council has passed the following resolution:

SECTION 1. Permission and authority are hereby given and granted to EXPRESS, upon the following terms and subject to the conditions of this ordinance to construct, install, maintain and use one (1) Banner(s) projecting over the public right-of-way adjacent to its premises known as 17 N. State St., (Said Banner(s) at N. State Street measuring (s): 1, (8.42) feet in width for a total of eight-point four (8.42) feet in width, and eight point four (8.42) feet in width for a total of eight-point four (8.42) feet in width.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1110851 herein granted the sum of seventy-five (\$75.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs

associated with damage, relocation or removal of private property caused by the City performing work in the public way.
