#### **ORDINANCE**

UNIVERSITY OF CHICAGO MEDICAL CENTER Acct.

No. 6533 - 14 Permit No. 1112340

### Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to UNIVERSITY OF CHICAGO MEDICAL CENTER, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, one hundred (100) Tieback System(s) under the public right-of-way adjacent to its premises known as 5700 S. Maryland Ave..

# Said Tieback System(s) at S. Drexel measure(s):

Nineteen (19) at thirty-seven (37) feet in length, and point five (.5) feet in width for a total of three hundred fifty-one point five (351.5) square feet.

#### Said Tieback System(s) at E. 57th St measure(s):

Fifty-eight (58) at thirty-seven point nine one (37.91) feet in length, and point five (.5) feet in width for a total of one thousand ninety-nine point three nine (1099.39) square feet.

#### Said Tieback System(s) at S. Cottage Grove measure(s):

Twenty-three (23) at thirty-nine point five eight (39.58) feet in length, and point five (.5) feet in width for a total of four hundred fifty-five point one seven (455.17) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1112340 herein granted the sum of four hundred (\$400.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way. Leslie Hairston 5th Ward
