WHEREAS, In 1968 Frank Gesualdo opened his first new car dealership at 105<sup>th</sup> Street and Michigan Avenue; and

WHEREAS, Over the years, Frank Gesualdo's business grew to become a large chain of car dealerships; and

WHEREAS, Frank Gesualdo also ran other automotive-related businesses, including a repossession business and a collection agency; and

WHEREAS, The hard work, sacrifice and dedication of Frank Gesualdo serve as an example to all; and

WHEREAS, His love of life and ability to live it to the fullest endeared Frank Gesualdo to his family members, friends and all who knew him, and enabled him to enrich their lives in ways they will never forget; and

WHEREAS, Frank Gesualdo will be dearly missed and fondly remembered by his many relatives, friends and admirers; and

WHEREAS, To his beloved family, Frank Gesualdo imparts a legacy of faithfulness, service and dignity; now, therefore
