ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION I. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the RS3 Residential Single-Unit (Detached House) District and RT4 Residential Two-Flat, Townhouse and Multi-Unit District symbols and indications as shown on Map No.1-H in the area bounded by

a line 253.08 feet north of and parallel to West Grand Avenue; North Claremont Avenue; a line 207 feet north of and parallel West Grand Avenue; and the alley next west of and parallel to North Claremont Avenue,

to those of a RT4 Residential Two-Flat. Townhouse and Multi-Unit District and a corresponding uses district is hereby established in the area above described.

SECTION2. This ordinance shall be in force and effect from and after its passage and due publication.

11. Current Use of the Property: The parcel at 520 North Claremont is currently vacant. The parcel at 522 North Claremont is developed with a 2-story (with basement) multi-unit residential building and a IV2 story (detached) coach house. The Applicant currently resides in the existing multi-unit building.

12. Reason for rezoning the property: The Applicant is seeking to amend the zoning at the subject property in order to develop the lot at 520 North Claremont with a new single family home. Today, the properties at 520 North Claremont and 522 North Claremont comprise one (1) zoning lot. The zoning amendment will allow the zoning lot to be divided.

13. Describe the proposed use of the property after the rezoning. Indicate the number of dwelling units; number of parking spaces; approximate square footage of any commercial space; and height of the proposed building. (BE SPECIFIC)

The Applicant is seeking to amend the zoning at the subject property in order to develop the lot at 520 North Claremont with a new, two-story, single family home. Today, the properties at 520 North Claremont and 522 North Claremont comprise one (1) zoning lot. The zoning amendment will allow the zoning lot to be divided. The proposed single family home at 520 North Claremont will be of masonry construction. It will be 24'-6" in height. There will be onsite parking for two (2) vehicles, for the new home, located at the rear of the lot. The existing 2-story (with basement) multi-unit residential building and 1 1/2-story coach house at 522 North Claremont will remain.

14.
