ORDINANCE

WHEREAS, the City of Chicago (the "City") is a home rule unit of government under Section6(a), Article VII of the 1970 Constitution of the State of Illinois authorized to exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the Cook County Board of Commissioners has enacted the Cook County Real Property Assessment Classification Ordinance, as amended from time to time (the "Classification Ordinance"), which provides for, among other things, real estate tax incentives to property owners who build, rehabilitate, enhance and occupy property which is located within Cook County and which is used primarily for industrial or commercial purposes; and

WHEREAS, the City, consistent with the Classification Ordinance, wishes to induce industry to locate, expand and remain in the City by supporting financial incentives in the form of property tax relief; and

WHEREAS, Fremont Square, LLC, a Delaware limited liability company ("the "Applicant") purchased certain real estate generally located at 900-910 West Weed Street, Chicago, Illinois 60642 (the "Subject Property"), as described on Exhibit A hereto; and

WHEREAS, the Subject Property is also sometimes referred to as 1550 North Fremont Street, Chicago, Illinois 60642; and

WHEREAS, the Applicant is now the sole owner of the Subject Property; and

WHEREAS, the Subject Property has undergone environmental testing and was found to contain certain adverse environmental conditions (the "Contamination"); and

WHEREAS, neither the Applicant nor the Applicant's owners are directly or indirectly responsible for creating the Contamination; and

WHEREAS, the Applicant has undertaken environmental remediation at the Subject Property and received from the Illinois Environmental Protection Agency's Site Remediation Program a "No Further Remediation Letter" dated January 25, 2013 and reissued February 20, 2013 (the "NFR Letter"); and

WHEREAS, the costs of remediating the Contamination at the Subject property exceeded \$100,000 in accordance with the eligibility requirements for Class C classification pursuant to the Classification Ordinance; and

WHEREAS, the Applicant has constructed a development consisting of an approximately 15,000 square foot retail building on the Subject Property (the "Development") to be used for commercial purposes in accordance with the eligibility requirements for Class C classification pursuant to the Classification Ordinance; and

WHEREAS, the Subject Property is located within the boundaries of Chicago Enterprise Zone Number 5 (created pursuant to the Illinois Enterprise Zone Act, 20 ILCS 665/1, et seq., as amended, and pursuant to an ordinance enacted by the City Council of the City), and the
