RESOLUTION CLASS 6(B) REAL ESTATE TAX INCENTIVE D£ IS£I<sub>0</sub> FOR THE BENEFIT OF MEADE ELECTRIC COMPANY, INC., AN ILLINOIS CORPORATION, AND REAL ESTATE LOCATED GENERALLY AT 6850 WEST 62 <sup>nd</sup> STREET IN CHICAGO, ILLINOIS PURSUANT TO COOK COUNTY, ILLINOIS

#### REAL PROPERTY ASSESSMENT CLASSIFICATION ORDINANCE

WHEREAS, the Cook County Board of Commissioners has enacted the Cook County Real Property Assessment Classification Ordinance, as amended from time to time (the "Ordinance"), which provides for, among other things, real estate tax incentives to property owners who build, rehabilitate, enhance and occupy property which is located within Cook County and which is used primarily for industrial purposes; and

WHEREAS, the City of Chicago (the "City"), consistent with the Ordinance, wishes to induce industry to locate and expand in the City by supporting financial incentives in the form of property tax relief; and

WHEREAS, Meade Electric Company, Inc., an Illinois corporation (the "Applicant"), owns certain real estate located generally at 6850 West 62<sup>nd</sup> Street, Chicago, Illinois 60638, as further described on Exhibit A hereto (the "Subject Property"); and

WHEREAS, the Applicant intends to substantially rehabilitate an approximately 178,000 square foot industrial facility located on the Subject Property; and

WHEREAS, the Applicant has filed with the Office of the Assessor of Cook County (the "Assessor") an eligibility application for a Class 6(b) tax incentive under the Ordinance; and

WHEREAS, the Applicant purchased the Subject Property for value; and

WHEREAS, at the time of purchase, the Subject Property had been abandoned for approximately twelve months; and

WHEREAS, the City's Department of Planning and Development has determined that certain special circumstances (the "Special Circumstances") justify a finding that the Subject Property is "abandoned" for the purpose of Class 6(b); and

WHEREAS, the Subject Property is located within the Harlem Industrial Park Conservation Redevelopment Project Area (created pursuant to the Illinois Tax Increment Allocation Redevelopment Act, 65 ILCS 5/11-74.4-1 et. seq., as amended, and pursuant to an ordinance enacted by the City Council of the City), and the purposes of Redevelopment Project Areas are also to provide certain incentives in order to stimulate economic activity and to revitalize depressed areas; and

WHEREAS, it is the responsibility of the Assessor to determine that an application for a Class 6(b) classification or renewal of a Class 6(b) classification is eligible pursuant to the Ordinance; and
